<u>Joint Meeting</u>. Asked if there was any input on the Interlocal Agreement and there was none at this time.

The District 26 & 28 lawyers have agreed in the language of the agreement. Salary's and future purchases will come out of what Fire 28 pays Fire 26. Fire 28 Insurance, elections they will pay.

Fire 28 held a public hearing on joining the 2 districts. Chief Andrews attended one of them. Seemed everyone was in favor of joining the 2 districts.

Pete spoke about the short time line and he is in favor of the merger, but doesn't weant it to go to a vote of the public right away. He thought November is too soon and would like to see it at a

later date.

A motion was made by Commissioner Tubbs to sign the Interlocal agreement and was seconded by Commssioner Olson. Motion passed. Will be effective March 1, 2017.

The group will need to pick a Chair and Vice Chair.

Discussion on date for meetings. A motion was made by Commissioner Tubbs and seconded by Commissioner Sample that we met the 2nd Wednesday of the month at 7PM and meet add months at District 26 and even months at District 28. Motion passed.
